I would just like to make note of some friendly reminders to help keep our village clean and intact.

Friendly Reminders:

After the trash pickup please move all trash bins from the curbside by 8pm on the day of pickup to avoid citation. Disposal of trash should be in the proper trash bins for pickup services. Any bulk items such as a couch or mattress will have to be coordinated through WISte management for a bulk item pickup and must have a plastic cover over the item for pickup.
